- 1. The competition may be attended by sport clubs and sport associations members. Competitors without any sport clubs and sport associations membership, without sport license and place of living have rights to start in Championships too.
- 2. The competitor is obligated to submit a written statement available in the competition office on the lack of health complications in order to participate in the Championship along with consent to the processing of personal data and publicizing of the image of the participant in promotional or advertising materials made available on the Internet, press, television and radio.
- 3. The right to participate in the Championships is awarded to contenders who pass through the entire registration process in accordance with all the points included in the application form available on the Facebook fan page of the Championships and the Championships website: www.stowarzyszeniemetroflex.pl and making a transfer within the starting fee of 200zł / 50€ for one discipline and 100zł / 25€ for every another one to the account number: 65 1750 0012 0000 0000 2045 2838.
- 4. Only booked the entry fee up to 22/08/2019 on the given account ends the process of full registration of the contender!
- In the title of the transfer please enter: MP start fee name and surname discipline,
 e.g.: MP start fee Jan NOWAK Barbell Bench Press or MP start fee Piotr KOWALSKI Powerlifting & Deadlift.
- 6. It is possible to pay the entry fee in the day of Championships foreigners only!
- 7. The registration fee is not refundable. After prior arrangement with the organizer, it is possible to transfer the starting fee to another contender.
- 8. Detailed information about the Championships will be regularly updated and updated on the Facebook fan page of the Championship and the Championships website: www.stowarzyszeniemetroflex.pl.
- 9. The registration fee includes a starter pack and catering voucher.
- 10. During the Championships, the organizer does not provide food other than a catering voucher in the starter pack.

- 14. Sportswear according to the CLASSIC RAW formula.
- 15. According to the provisions of the Federation of WPC POLAND, it is possible to weigh in on the day before the start of the competition.

VII. SAFETY PRECAUTIONS

- 1. The participant is obligated to submit a written statement available in the competition office on the lack of health complications, to be able to participate in the Championships.
- 2. Participants of the competitions are required to comply with all organizational arrangements related to staying at the Multifunctional Sports Hall of the University of Physical Education in Wroclaw.
- 3. Competitors are required to comply with the regulations of AWF sports facilities in Wroclaw.
- 4. Regulations are displayed in places visible at the entrance to the facility.
- 5. All injuries, traumas, and instances of illness should be reported immediately to the medical squad of the Championships.
- 6. The organizer does not take responsibility for insurance of players and accompanying persons against accidents occurring during the Championships.
- 7. Detailed safety conditions regarding competition will be presented by the Main Referee during the technical briefing.
